Competencies and Duties

This position requires someone with a passion for program evaluation as well as training and experience in evaluation planning, data collection, data management and analysis, reporting, and facilitating client relationships and learning. Depending on a candidate's level of training and experience, this position could be entry-level (Research Associate) or more advanced (Evaluator).

- Strong communication skills with internal and external stakeholders
- Ability to manage time to successfully address both urgent and non-urgent but important tasks
- Strong desire to learn and adapt
- Ability to work independently and as part of a collaborative team
- Knowledge of program evaluation approaches and research methods
- Experience collecting, analyzing, and reporting quantitative and/or qualitative data
- Advanced knowledge of Microsoft Excel including pivot tables, formulas, graphs, etc.
- Experience with SPSS, R, or other statistical software
- Experience with data visualization tools such as Tableau, R, Microsoft Bl
- High level of comfort learning and using technology to manage time and projects
- Knowledge of HIPAA, FERPA, and human subjects research



Specific tasks include, but are not limited to:

- Create or refine evaluation plans, logic models, and theories of change.
- Design or adapt data collection instruments such as surveys, interview or focus group protocols, observation forms.
- Identify and use secondary data sources (including but not limited to electronic medical record data).
- Monitor data collection for completeness and quality.
- Use statistical software to clean, recode, merge, and transform datasets. Perform basic descriptive and inferential statistics.
- Organize and code qualitative data, and identify themes and patterns in the data.
- Design and implement data quality assurance procedures.
- Create graphs, tables, and other figures for evaluation reports using best practices in data visualization techniques.
- Contribute to writing evaluation reports and project proposals.

A candidate may have more in-depth knowledge and experience in specific content areas or evaluation methods.

Core Values
