Well Child Checks - Quantity	Percentage of unduplicated SBHC users, aged 3 to <21 years, seen during the measurement year who had at least one comprehensive well-care visit provided in past 12 months at the SBHC, including documentation of health and developmental history, physical exam, health education/anticipatory guidance, and annual risk assessment.	We will improve the health of our users by increasing to 75% the percentage of SBHC users with an annual WCC by June 30.	
Tdap Immunization	Percentage of unduplicated SBHC users who have received Tdap or Td vaccine by their 13 th birthday.	We will decrease preventable disease by increasing the percentage of users 13 and older with documented Tdap to 85% by June 30.	
Meningococcal Immunization	Percentage of unduplicated SBHC users who have received meningococcal vaccine by their 13 th birthday.	We will decrease preventable disease by increasing the percentage of users 13 and older with documented meningococcal vaccine to 85% by June 30.	
HPV series	Percentage of unduplicated SBHC users who have received HPV series by their 15 th birthday (with appropriate spacing between vaccines).	We will decrease preventable disease by increasing the percentage of users 15 and older with documented completed HPV series to 85% by June 30.	
Oral Health	Percentage of unduplicated SBHC users aged 3 to <21 years seen during the measurement year with documentation of an oral health screen in the past 12 months, by the SBHC PCP <u>OR</u> by SBHC dental professional.	We will improve the oral health of our users by increasing to 75% the percentage of SBHC users who had a documented oral health screen by the SBHC PCP by June 30.

BMI Assessment with Nutrition and Physical Activity Counseling	Percentage of unduplicated SBHC users seen aged 3 to <21 years seen during measurement year with documentation of the following in the past 12 months: BMI percentile AND counseling for nutrition AND counseling for physical activity	WE will improve the health of our users by increasing to 90% the percentage of SBHC users with documented BMI% and nutrition and physical activity counseling by June 30.	
Depression Screen	Percentage of unduplicated SBHC users aged 11 to <21 years seen during the measurement year with documentation in the past 12 months of screening for clinical depression using an age appropriate standardized tool AND follow-up plan documented if positive screen.	We will improve early identification of depression by increasing to 85% the percentage of users 11 years to <21 years screened for depression by June 30.	
Chlamydia Screen	Percentage of unduplicated SBHC users (all genders) seen during the measurement year identified as sexually active who had ≥1 test for Chlamydia documented in past 12 months.	We will improve the health of our users by increasing to 85% the percentage of users identified as sexually activity with at least 1 test for Chlamydia by June 30.	
Adolescent Risk Assessment (Middle School and High School)	Percentage of unduplicated SBHC users aged 11 to <21 years seen during the measurement year with ≥1 age-appropriate, annual risk assessment in the past 12 months.	We will improve identification of risk behaviors by increasing by 75% the percentage of users 11 years to <21 years who have been received a comprehensive risk assessment by June 30 from previous year.	
Billing	Total insurance revenues during measurement year, public and private.	We will increase sustainability by increasing total insurance revenues by 10% by June 30 from previous year.
